Purpose of job	Support pupils during the lunch break, take a lead in developing positive behaviour amongst pupils, organise and lead play activities and maintain play equipment
Normal base of work	As stated in the contract however, there may be some requirement to work from other Five Rivers Trust sites as appropriate.
Safeguarding statement	Five Rivers MAT is committed to safeguarding and promoting the welfare and safety of children and expect all staff to share this commitment. The successful candidate will be required to complete a Disclosure Barring Service check in line with Section 115 of the Police Act 1997.
	This post is exempt under the Rehabilitation of Offenders Act, so all criminal convictions must be stated, with dates. Failure to do so will disqualify individuals from appointment and, if appointed may render them liable to immediate dismissal without notice.
	An individual disqualified from working with children through any of the various means available is guilty of an offence if he or she knowingly applies for or accepts any work in a regulated position i.e. classified as working with children (Criminal Justice and Court Services Act 2000).
	The Five Rivers MAT will only offer appointments if the above checks are satisfactory; and will allow no unsupervised access to children before completion of all checks.

JOB DESCRIPTION: MIDDAY SUPERVISOR

The post holder must, at all times, carry out his / her duties and responsibilities within the spirit of the Five Rivers Multi Academy Trust, the Trust's policies and within the framework of the Education Act 2002 and the School Standards

Main Duties and Responsibilities

To work as part of a team supervising pupils during the school lunch break, which includes attending to their welfare and domestic needs.

Specific responsibilities will include:

- 1. Contributing to the development of a positive approach to lunchtime play.
- 2. Providing support and counselling for children finding it difficult to cope in the playground.
- 3. Preparing lunchtime games and activities in conjunction with other the senior play worker and other play workers both outside and inside.
- 4. Leading activities and participating in play activities with children.
- 5. Organising and maintaining play equipment, ensuring its safe storage.
- 6. Working with the other play workers in delivering lunchtime play activities.
- 7. Attending staff meetings and staff development meetings when appropriate.
- 8. Maintaining records of pupil behaviour where necessary.
- 9. Establishing and maintaining relationships with other school staff and where appropriate with parents.
- 10. Participating in the school scheme of appraisals and performance management.
- 11. Undertaking any other duties and responsibilities after appropriate negotiations with the postholder and trade unions, which do not change the nature of this post.
- 12. To supervise children during their outdoor / indoor play experience during lunchtime.

- 13. To supervise children in transition from outside/inside during inclement weather.
- 14. To ensure the standards of behaviour are maintained and comply with school behaviour policy.

Any other duties and responsibilities appropriate to the grade and role

All of the above duties and responsibilities to be carried out in accordance with Five Rivers MAT's policies, national legislation, equal opportunities, data protection and Health and Safety.
